On behalf of NAF, I want to thank you for your leadership in championing the Jumpstart Our Businesses by Supporting Students (JOBS) Act of 2025 which supports federally funded workforce opportunities through career and technical education.

Our academies are integrated into existing public high schools and put students — especially students who may lack access - on a path to achieving their full potential. We are committed to ensuring educators, local education agencies, and workforce development boards work seamlessly together to support college and career readiness programs for our nation's high school students. Given our 45 years of experience, we uniquely understand the need for a wide array of workforce programs and opportunities to pique a student's interest in a potential career pathway. Short-term training programs that provide students with a necessary credential or critical experience that can jumpstart their career is one such way for students to reach their full potential. NAF supports the JOBS Act in providing students with the opportunity to gain training and/or credentials through Pell Grant funding. These programs can spur a student's career interest and therefore is a critical component of building robust connections between education and workforce systems across the country.

As you and your colleagues continue to push for the broadening scope of Pell Grants, NAF also encourages the extension of Pell Grant eligibility to cover dual enrollment courses.
